JUDGMENT
(ON AN APPLICATION TO MODIFY THE AUTHORIZATION APPLICATION AND TO
TEMPORARILY STAY THE CLASS ACTION)

- [1] **CONSIDERING** the Applicant's *Application for Permission to Amend and to Temporarily Stay the Class Action* (the “**Application**”), whereby the Applicant requests to notably limit the class description to Quebec residents only and that the class action against the Defendants be temporarily stayed until COMCO releases the findings of its investigation;
- [2] **CONSIDERING** that the Defendants do not oppose and take no position on the Applicant's Application, it being agreed and understood that the requested stay is without prejudice to any of the rights of the Defendants, including the right to contest jurisdiction, and that the Defendants do not thereby waive any procedural or substantive rights when the Plaintiff asks for the stay to be lifted or when the stay is lifted;
- [3] **CONSIDERING** that the Court is satisfied that the Applicant's Application has regard for the protection of the rights and interests of Quebec residents;
- [4] **CONSIDERING** that the requested stay is consistent with the principles of proportionality and judicial economy;
- [5] **CONSIDERING** articles 18, 49, 157, 577 and 585 C.C.P.;
- [6] **CONSIDERING** that Class Counsel has undertaken to provide this Court with any major update on the status of COMCO's investigation, and to advise this Court within 30 days of any significant development in the investigation that may affect the course of this class action;
- [7] **CONSIDERING** the submissions of counsel for the Applicant and counsel for the Defendants and the representations made on all sides;
